

Station Ideation - A Minecraft Mission Terms and Conditions

TERMS AND CONDITIONS

This document sets out the Terms and Conditions for the 2022 'Station Ideation - A Minecraft Mission' Competition.

Background

1. The 2022 'Station Ideation – A Minecraft Mission' competition (the **Competition**) is being run by the Victorian Government Department of Education and Training (the **Department**), ABN 52 705 101 522, 2 Treasury Place, East Melbourne, Victoria 3002. Phone enquires can be directed to the Department on (03) 7022 1497.
2. By entering the Competition, an entrant agrees to be bound by these Terms and Conditions.
3. The Department may in its absolute discretion refuse to award a prize to any entrant who fails to comply with these Terms and Conditions.

Entry requirements

4. To enter the Competition, an entrant must submit a narrated video (up to 5 minutes length) created by students at the school showcasing their design of Town Hall Station, Melbourne in Minecraft. This must be accompanied with the student design portfolio.
5. Entries **must** be submitted by completing the Competition entry form provided by the Department.
6. A teacher at the school must enter the Competition on behalf of students.
7. The Competition opens at 12.30pm AEST 2 March 2022 and closes at 5.00pm AEST on 8 June 2022.
8. Entries submitted after 5.00pm AEST on 8 June 2022 will not be eligible to win the Competition.

Eligibility

9. Entry to the Competition is open to government schools in Victoria and must be created by students at the school in years 5, 6, 7 or 8.
10. Entry is not open to any person associated with the Competition, or with the provision of the prize, or their immediate families.

Consent

11. Entrants must obtain the written consent of all students and staff who are involved or feature in the entry for the video to be published on the Department's social media channels and on digital screens at Metro Tunnel HQ.
12. Where a student involved in the creation of or featuring in the video entry is under 18 years of age at the time of submission of the entry, written consent on behalf of the student to publishing the video in the ways described at paragraph 11 must be obtained from a parent/guardian of the student.

Prize

13. The Department will award one prize to a winner in each age category of years 5-6 and years 7-8.
14. The prizes for the Competition are as following:
 - a. The winning entry will have their Minecraft world showcased on digital screens at Metro Tunnel HQ, 125-133 Swanston Street, Melbourne VIC 3000; and
 - b. The winning team will also receive a Minecraft prize pack worth \$200, donated by Microsoft Education.
15. The winner will be contacted by email prior to being featured at Metro Tunnel HQ.

16. The prize is not transferable or exchangeable.
17. The Department reserves the right to withdraw the prize in the event of an entrant being unable to satisfy these Terms and Conditions.

Judging

18. The winning entry will be selected by the judging panel after the Competition closing date and time.
19. Entries will be judged against the criteria contained in the project rubric for the Competition. This can be found in the teacher resource and student design portfolio.
20. This is a contest of skill, judged on the merits of each entry. Chance will not play a role in determining the Competition winner.
21. The judges' decision will be final, and no correspondence will be entered into. Individual feedback to entrants will not be available.

Nature of entries

22. All entries are subject to moderation and an entry may be rejected if, at the absolute discretion of the Department, the entry:
 - a. contains offensive language or is derogatory or threatening in any way;
 - b. contains material that conveys hatred or harm against any group or person, or otherwise does not comply with the theme and spirit of the Competition;
 - c. contains personal or sensitive information;
 - d. is unlawful or violates an individual's rights;
 - e. is incomplete, indecipherable or illegible; or
 - f. contains any content, material or element that is shown to be the property of any third party.
23. The Department reserves the right to verify the identity of the entrant and where a student is under 18 years old, that the entrant has obtained the necessary permission of a parent/legal guardian of that student involved in or featured in the entry.
24. An entry must be substantially the own work of students of the entrant and have no overt assistance from teachers, family or friends.
25. An entry which infringes an existing copyright will be disqualified from the Competition.
26. The Department will exercise its judgement in ruling on questions of eligibility. The ruling of the Department on questions of eligibility will be final, and no further correspondence will be entered into.
27. The Department reserves the right to disqualify any entrant it finds to be acting dishonestly or in violation of these Terms and Conditions.

Intellectual property and licensing

28. All video entries, completed assessment rubrics and any other material submitted in connection with the Competition are assigned to the Department upon submission and become the property of the Department which may use the material in any medium in any reasonable manner associated with the Competition. Copyright in all submitted material remains the sole property of the Department.
29. Each entrant:
 - a. warrants that it owns the copyright and any other intellectual property rights in any material submitted and has the power and authority to agree to and grant the above assignment, consents and other rights to the Department;
 - b. indemnifies the State of Victoria, and all officers, servants and agents of the State of Victoria against any action, claim, suit or demand, including a claim, suit or demand for or liability to pay compensation or damages and costs or expenses arising out of or in respect of any breach of any third party's intellectual property rights; and

- c. gives the Department all necessary consents (including any consent required in relation to moral rights), to allow the Department to adapt or change any part of the video from the entrant's entry in any way without attributing the entrant or any other person as a creator of or contributor to that video.

Privacy Policy

30. The Department takes its privacy obligations seriously and any personal information collected or used by the Department will be handled in accordance with the *Privacy and Data Protection Act 2014 (VIC) (PDP)*. This law sets out what the Department must do when it collects, uses, handles and destroys personal information. Personal information includes personal details such as an individual's name and school that could be used to identify an individual.
31. Any personal information required for entry into the Competition will only be used for purposes related to the Competition. The Department will treat any personal information obtained from a person who enters the Competition in accordance with the Information Privacy Principles contained in the PDP.

Disclaimer

33. The Department is not liable for any costs incurred by the entrants due to their participation in the Competition, or any loss or damage arising from use or ownership of the prize.
34. The Department reserves the right to cancel, suspend and/or modify this Competition, or any part of it, if any fraud, technical failures, or any other factor beyond the control of the Department impairs the integrity or proper functioning of the Competition, subject to Victorian law. If the Competition is terminated, the Department may in its absolute discretion, determine the winner from among all eligible entries received up to the time of termination.
35. No claim is made as to the accuracy or authenticity of the content of the Competition website. The Department does not accept any liability to any person for the information or advice (or the use of such information or advice) provided on this website or incorporated into it by reference.
36. In the event of force majeure or if circumstances so dictate, the Department reserves the right to suspend, postpone or cancel the Competition at any time and without prior notice, in which event entrants will not be entitled to claim compensation in any form.
